# SPRING 2025 GATHERING REPORT

#### Introduction

There were presentations delivered by First Nations' Emergency Services Society (FNESS), Indigenous Services Canada (ISC), BC Housing, First Nations Market Housing Fund (FNMHF), Kanaka Bar, and Tkemlúps te Secwépemc (TteS) with some fun along the way.

### Housing Resources Service Update

Rick and Ruth provided the Housing Resources Service (HRS) update since the last gathering in the fall.

#### Circuit Rider Initiative

The Circuit Rider initiative was presented, and the communities were asked to give some thought to their specific community housing needs and how the Circuit Rider could be of assistance. After much planning, HRS decided the best way to deliver the Circuit Rider concept will be to accept 2 or 3 communities who would like assistance in things like planning, program delivery and accessing program funding. The direction would come from the communities and the Circuit Rider would work alongside the Housing Manager. More information will be provided as the initiative progresses.






#### Financial Learning Survey

The reasons behind the online Financial Learning Survey were explained to the participants. The goal behind the survey was to gain accurate information about what kind of financial resources are needed in communities. Since the beginning of HRS, the feedback from communities continues to be that Housing Managers and staff want to learn more about budgets and finances. HRS would like to know more specifically what that means. So, the Financial Learning Survey was developed to gather more specific information.

Results from the survey reveal that most Housing Managers who responded play an active role in creating annual budgets and actively monitor those budgets throughout the year. Most respondents have worked with a budget prior to their roles as Housing Manager and feel knowledgeable about how to read and interpret budgets. Most respondents selected "Somewhat" for "I feel very knowledgeable about how to create a construction budget". There was a strong response to benefitting from a basic financial literacy session on budgets and the vote was split on having a working knowledge of Excel to manage a Housing budget.

Here are some of the comments submitted by the respondents for further information or education/training needs: Forecasts and planning; How to create an Excel spreadsheet for a construction budget; Housing accounting systems; More about budgets; Apps for billing and invoicing; budget priorities; Reporting; Future planning asset needs versus budget; Project cost tracking; How to read budgets; How to create a construction budget; How to create a maintenance budget; Learn about MLG's and how they can be used; Sec.95 budgets, do they cover the operation of the phase?; General Contractor tender documents; Replacement Reserve budgets; Assessing bids; Excel templates; Calculating maintenance fees homes without a mortgage; How to stack funding; Have the opportunity to work on creating schedules for housing financial statements.





### **Virtual Winter Gathering**

We meant to mention the Virtual Winter Gathering that HRS hosted on February 25<sup>th</sup>. The virtual gathering was well attended and so well received that we invited Wendi Omeasoo from First Nations Emergency Services Society (FNESS) to present at the Spring Gathering.

### Emergency Preparedness and Emergency Operations Centres

We are very thankful Wendi accepted our invitation and delivered a very informative and important presentation that encouraged everyone to not only process the information about emergency preparedness from a personal perspective, but also from the perspective of each person's role within the Housing Department. Climate change is causing dramatic increases in wildfires, floods and landslides and the more people who learn how to be as prepared as possible for such things, the better we will be in the case where we must respond to an emergency.

In addition to Emergency Preparedness, Wendi shared her knowledge of Emergency Operation Centres; when they are put in place, roles and responsibilities and how communities are funded to operate these centres. It was noted that there have been some serious fails in the past with how First Nations communities were treated during wildfire and flood evacuations and some improvements have been made.







There is still work to be done and one key factor in ensuring improvements are made is by having Community Liaisons who know their community and will advocate for culturally appropriate, fair and safe treatment of their community members in the case of these traumatic times.
